- Studying the status and condition of Dalits in India; studying the rights violated by citing examples; and also, stating various legal safeguards available to protect Dalits;
- Studying the status of Ethnic Minorities and understanding challenges they face;
- Studying the status of Migrant Workers in Indi by citing examples;
- Studying the status of 'Displaced Persons' in India by citing examples; analyzing
 different causes responsible for displacement; and also, stating various legal remedies
 available for their protection;
- Studying the status of Indigenous Peoples worldwide; understanding the conditions of Indigenous Peoples; and identifying their various rights violated by citing examples

CO 6: Studying the impact of terrorism in India by citing examples
