Dear Ms. Saranya Banerjee,

On recommendation of the Selection Committee at its meeting held on July 26, 2023, I am pleased to appoint you as Contractual Full-time Faculty Member in Psychology under the Faculty of Arts and Social Studies at St. Xavier's University, Kolkata with effect from August 1, 2023 till December 31, 2023. You will receive a consolidated salary of Rs. 55,000/- per month during this period.

You will be required to take at least 16 hour of classes per week. In addition, you will be required to be engaged in the examination process of the University and to take part in co-curricular and extra-curricular activities of the University, as and when required. For any matter relating to discipline, you are to report to the Dean of your Faculty and Heads of the Department.

You are to open a Savings Bank Account with either Canara Bank, St. Xavier's University Rajarhat Campus Branch or ICICI Bank, Karigari Bhawan Branch for the payment of your salary.

The terms and conditions of your service will be as follows:

1. After joining, you will be governed by the service rules and regulations including conduct and administrative orders of the University in existence and as framed and/or amended from time to time.
2. Your salary/emoluments are subject to statutory deductions, as applicable.
3. Your service may be terminated by giving one month's notice in writing by either side or on payment of one month's salary in lieu thereof. However, in case you initiate termination of services during the period, while a particular semester is in progress, it shall be the discretion of the management to relieve you from the services of the University during that time.
4. During the period of your employment with St. Xavier's University, Kolkata, you will not take up any other employment or assignment, honorary or for any consideration, without prior written permission of the competent authority of the University.
5. This appointment is on the basis of details of qualifications, experience, degrees, certificates, diplomas and other relevant data given in your application/resume and/or provided by you to the University at the time of your interview or at the time of joining.



6. If at any time in future, it transpires that any declarations given by you or any information furnished by you is false or it is found that you have suppressed any fact or material information, the competent authority would take such action as it deems fit at its sole discretion including termination of your services.
7. You may be required to work or you may be transferred to any other Faculty/School/Department of the University, if required.
8. You may be given any other work related to academics which will be assigned by the undersigned.

On behalf of the University, I welcome you to St. Xavier's family with the belief that you will give your best and uphold the values of our institution.


The monthly pay will be released subject to the availability of funds from the M.Phil in Clinical Psychology (self financing) course.
