The Department of Library & Information Science, University of Calcutta invites potential authors to submit unpublished and original papers for the upcoming issue of the Calcutta University Journal of Information Studies (CUJIS) which is a peer-reviewed academic journal published annually, and a completely non-profit publication, funded by the University of Calcutta, West Bengal, India. The CUJIS, as a peer-reviewed journal, complies with the standard norms as per the UGC recommended suggestive parameters.

The submissions must be original works written in English. Manuscripts for research articles should comprise *not more than 3000 words* in length, and please ensure your submission conforming to our journal's Author Guidelines as well as Submission Guidelines. The manuscripts for research articles will be subjected to a *double-blind peer-review*.

### Formatting

Manuscripts should be in MS Word format, set in **Times New Roman** with minimal formatting (for English) and the **Kalpurush** (for Bengali). The full paper should include the title (16 pt. bold), sub-title (if any, 14 pt. bold), name of the author(s) (14 pt. bold) with designation(s)/affiliation(s) etc. (12 pt.). The length of the paper should be within 4-5 pages (of A4 size, margin: Left: 1.25" & Top, Bottom, Right: 1" each) including abstract, tables & figures, annexure and references.

Avoid unnecessary abbreviations. Necessary abbreviations should be written accordingly: *ibid.*; *et al.*; *no.*; *i.e.*; *e.g.*; *etc.* Avoid bold or underlined letters. References should be given in *APA style format (7<sup>th</sup> Edition)*.

### Illustrations and Photographs

It is possible to include illustrations and photographs in the manuscript as long as they are directly relevant to the discussion. You can embed illustrations and photographs in the main document as this makes the review process easier, but all illustrations, including pictures, tables, and diagrams, should also be submitted separately, preferably in *.jpg*, *.jpeg* or *.tiff* format.

## Author Guidelines

### Title

The title should be concise, omitting terms that are implicit and, where possible, be a statement of the main result or conclusion presented in the manuscript. Abbreviations should be avoided within the title.

### Authors should avoid:

- titles that are a mere question without giving the answer
- unambitious titles, for example starting with 'Towards,' 'A description of,' 'A characterization of' or 'Preliminary study on'
- vague titles, for example starting with 'Role of', 'Link between', or 'Effect of' that do not specify the role, link, or effect
- including terms that are out of place, for example the taxonomic affiliation apart from species name.

### Sections

The manuscript is organized by headings and subheadings. The section headings should be those appropriate for your field and the research itself. You may insert up to 5 heading levels into your manuscript (*i.e.*,: 3.2.2.1.2 *Heading Title*).

For Original Research articles, it is recommended to organize your manuscript in the following sections

### Abstract

- The abstract should be **informative and structured** containing the following key points:  
*Introduction, purpose, design/ methodology approach, findings, originality and conclusion.*
- The word length of the abstract should not exceed 300.
- A maximum of 5 keywords will be allowed.

## **Main Content**

### **Introduction**

Succinct, explicit with no subheadings.

### **Materials and methods**

This section may be divided by subheadings and should contain sufficient details, such as methods and designs opted and materials used, so that when read in conjunction with cited references, all procedures can be repeated.

### **Results**

This section may be divided by subheadings. Footnotes should not be used and must be transferred to the main text.

### **Discussion**

This section may be divided by subheadings. Discussions should cover the key findings of the study.

### **References**

As per the APA 7<sup>th</sup> edition guidelines.
