 Academic Orientation for First-Year Students

Duration: 10 sessions (45 mins each class)

Audience: First-year Political Science Honours students

Purpose: To bridge the gap between school-level understanding and university-level expectations in Political Science, while also orienting students to the institutional, curricular, and assessment structure.

Course Structure

1. What is Politics? Political vs. Non-political; Political Theory vs. Political Science; Understanding of politics in everyday life.
2. Concept of Power and Authority. Discussion on contemporary understanding of political power.
3. Concepts of State, Nation, Sovereignty, law, liberty.
4. Politics and Media.

5. Justice, Equality, Fraternity; Rights, Justice, Freedom.
 6. Democracy and Authoritarianism. Features of authoritarian regimes Debate: "Is India truly democratic?"
 7. Political Obligation and Citizenship. Why obey laws? Active vs passive citizenship; Civic duty
 8. Introduction to Political Ideologies.

SEC- 1- Democratic Awareness through Legal Literacy

Learning objectives:

1. To introduce students to the basic concepts of law and its role in a democratic society.
2. To develop an understanding of the evolution and structure of the Indian legal system, including the shift from colonial laws to citizen-centric reforms like the BNS and BNSS.
3. To familiarize students with different branches of law (constitutional, civil, criminal, personal, labour, environmental) through relatable examples.
4. To encourage critical thinking and civic responsibility by connecting laws to contemporary social issues and everyday experiences.
5. To identify and apply basic legal principles governing agreements, consumer rights, digital conduct, and citizen-state interaction.
6. Critically examine the balance between state security and individual liberty, especially in the context of anti-terror laws and preventive detention.
7. To engage as informed citizens, capable of using law to assert rights and seek remedies in civic, consumer, and digital contexts.

Learning Outcomes:

It is intended that at the end of the course students will-

1. Demonstrate a foundational understanding of the importance of law in protecting rights and maintaining justice in a democracy.
2. Be able to identify and classify different kinds of laws and legal frameworks applicable in various situations.
3. Develop an awareness of the laws that protect vulnerable sections of society such as women, children, and marginalized communities.
4. Engage in informed discussions and reflect on the role of legal literacy in responsible citizenship and social change.
5. Recognise their rights and duties in commercial, digital, and civic contexts.
6. Participate confidently in public discourse on the balance between security and human rights.
7. Approach authorities and grievance redress mechanisms effectively when legal challenges arise.
